5. Ordinance No. O-19-18: Amending the Village of Volo Zoning Ordinance Regarding Adult-Use Cannabis Business Establishments

The Village Board will consider approving Ordinance No. O-19-18, amending the Zoning Ordinance to establish regulations for adult-use cannabis business establishments.

The proposed amendments would establish adult-use cannabis businesses as permitted uses in specific zoning districts, subject to certain regulations, including setback requirements from residential and sensitive uses (schools, parks, etc.).

6. Ordinance No. O-19-19: Amending Title 3 of the Village of Volo Municipal Code Pertaining to the Imposition of a Municipal Cannabis Retailers' Occupation Tax

The Village Board will consider approving Ordinance No. O-19-19, imposing a Municipal Cannabis Retailers' Occupation Tax at the rate of 3% of gross receipts.
